Use CCA School Backpack Safety Checklist

This time of year marks the annual march back to school by hundreds of thousands of children. Laden with an ever-increasing number and size of textbooks, your patients' – and prospective patients' – kids are risking serious, lifelong back trouble from improperly packed or worn backpacks. CCA suggests that doctors with patients who are parents of school-aged children be made aware of important the safety tips for purchasing and using backpacks contained in the "CCA Backpack Safety Checklist."

CCA Backpack Safety Checklist

What to look for in a backpack:

- Choose a backpack that is sturdy and correctly sized
- Padded shoulder straps and back
- Lumbar support and a waist belt
- Multiple compartments

How to wear a backpack:

- Load heavier items closest to the back
- The total weight of the loaded backpack should not exceed 15 percent of the child's weight
- Wear both shoulder straps at all times
- Tighten straps until snug, but not tight
- Use the stabilizing waist strap
- Take the backpack off when standing still


