## BCE Enacts Re-Licensure Fee & Fingerprints Regulations

On January 1, 2011, the BCE implemented the increased annual license renewal fee enacted by AB 1996, Jerry Hill, D-San Mateo. The fee increased from \$150 to \$250.

The BCE also passed a regulation requiring licensees who have either not previously submitted fingerprints to the BCE, or who were initially licensed prior to January 1, 1997, or for whom a record of an electronic submission of fingerprints no longer exists, to submit fingerprints electronically. Licensees are required to comply by the licensee's renewal date that occurs on or after June 1, 2011. Here's the process:

1. Print and complete the "[Live Scan Service Instructions and Form](#)"
2. Click this [link](#) or the link on the form to locate places where a live scan can be conducted. About one-third down the form there is a place to enter your address. By doing so, a map will pop up with balloons showing live scan facility locations. Clicking on the balloon, shows the name and address of the business with a link to obtain directions. Or scroll down further to find locations listed by county/city.
